WAIVER AND RELEASE OF LIABILITY

I UNDERSTAND AND AGREE THAT THE ORGANIZERS WILL NOT PAY FOR ANY COST OR EXPENSE INCURRED BY ME IF I AM INJURED.

- I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE ORGANIZERS or others, and I assume full responsibility for my participation. I willingly agree to comply with the stated and customary terms and conditions for participation.
